#### Summary

Direct impacts from vessels present a threat to the protection and health of Florida Keys National Marine Sanctuary resources. More than 300 vessel groundings (vessels 50 feet or less; FKNMS unpub. data) are reported annually within the sanctuary, causing physical damage to resources such as seagrass, hard-bottom, and coral reef habitats. In addition, there are a variety of direct impacts from smaller commercial and recreational vessels that may not result in actual groundings but still impact sanctuary resources. The Sanctuary Advisory Council heard a presentation on Coast Guard Auxiliary Boater Education on February 19, 2013 and discussed boater education at the August 20, 2013 meeting. No motion was developed, but the advisory council determined that the next steps would be as follows:

"The Advisory Council will form a subcommittee to engage with Florida Fish & Wildlife Conservation Commission Boating Advisory Council to:

- · Host a joint meeting / workshop, and
- Present Florida Keys National Marine Sanctuary boating and boating education issues to the Boating Advisory Council."

1:30 Boater Education Programs: Phil Goodman, USCG Auxiliary and Sanctuary Advisory Council (Discussion and potential action)

#### **Boater Education/Licensing**

- Jessica Pulfer: Consider ways to get more people to take the current boating course (State). Accidents are often from individuals who don't have safety training.
- Rob Mitchell: Consider providing rental companies with more information and training for employees. (Note: It was explained by FWC that they have very strict rules regarding liveries and rental vessels and a training course is mandatory for boat rental operations.)
- Don Kincaid: According to Florida Trends magazine Monroe County leads nation in boating accidents, but only 8-10% accidents in Monroe County are by residents.
- George Garrett: Channel marking plan is both a navigation and resource protection plan.
- Chairperson Nedimyer: Most of the current boater courses are geared toward safety and
  navigation and not necessarily protecting resources. Many places are without channel
  markers and people need to know what they are doing to avoid damaging resources.
- Jessica Pulfer: If it's not feasible to have a Coast Guard course just for the sanctuary then
  maybe a specialty course could be an avenue for getting specific information on navigating in
  the Keys. The course could have incentives and tie back to sanctuary. (Sanctuary
  information is taught as part of the auxiliary boating and safety course.)
- Jerry Lorenz: Suggests considering an online course that mirrors the Eco-mariner course, especially to address non-residents.
- Julio Jimenez (audience member, FDEP Coral Program). Suggested the possibility of tying
  passing the course with lowered insurance rates for boaters (some companies have this
  already).
- Chairperson Nedimyer: Mandatory boating license should be necessary in Keys, but may not be feasible.
- Ben Daughtry: Due to budgetary constraints, an online course that mirrors the Eco-mariner course could be good. It is apparent that a large portion of boaters are using their own boats or bringing their boats down and they need to be reached regarding sanctuary waters. Ben offered to provide a motion to promote a mandatory course for the sanctuary. (No formal motion was made. The sanctuary superintendent can also take direction/advise from the council.)

## February 19, 2013 SAC meeting

#### **Discussion – Boater Education (continued)**

The following comments were made after the boating presentation regarding boater education.

- David Hawtof: State should have a boating license for everyone to help solve this problem.
- Rob Mitchell: He would like to see a state license, too. Instead, though, maybe boaters in the sanctuary could be required to have safety card through Coast Guard, Blue Rider, FWC, etc.
- David Makepeace: Keys boater license is unrealistic. Incentive programs are fine, though.
   This is a unique area and it might be best to ask state and others to partner with the sanctuary on evaluating possible solutions.

Chairperson Nedimyer asked the Sanctuary staff to work with agencies on a boater education and the potential for mandatory programs including licensing.

Superintendent Morton recognized that a mandatory boating license may not be feasible. The Sanctuary will work with the State and will provide a review and options for SAC consideration.

# V. MARINE ZONING AND REGULATORY REVIEW: FLORIDA BOATER EDUCATION PROGRAMS

Mr. Todd Hitchins, FKNMS Team O.C.E.A.N Coordinator, gave a presentation on boater education program in the sanctuary. Mr. Hitchins noted that there has been interest in the topic of boater education and how education can help mitigate impacts to the resources. Many of the existing boater education classes emphasize boating safety and seamanship.

Potential next steps include engaging with the FWC Boating Advisory Council, which will be meeting in Key West in May 2014. Suggestions included presenting Keys boating issues to the Boating Advisory Council and/or hosting a meeting/workshop.

#### **Discussion** (council members)

A suggestion was made for FWC to consider developing a partnership with local or regional retailers to provide card holders with a discount of sorts as an incentive to get more people to take the course. More marketing on the card to make people aware of its existence was also suggested.

Superintendent Morton explained that he presented in front of the FWC Boating Advisory Council at their request in April 2013. He reviewed the boater education issues that arise in the sanctuary and the council addresses similar issues and was very interested the work of the sanctuary advisory council. The Boating Advisory Council is planning to meet here in Key West and a subcommittee of the advisory council could be formed to work with them and generate specific topics that should be addressed. Recommendations from Shallow Water Wildlife and Habitat Protection Working Group that relate to groundings could be forwarded to this council. This is the right forum for addressing in county and out of county boaters. Sanctuary advisory council members supported this idea of forming a subcommittee to meet with the FWC Boating Advisory Council.
